UNDER SECTION 42 OF THE COMPANIES ACT, 2017

Whereas it has been proved to the satisfaction of the Securities and Exchange Commission of Pakistan (the "Commission") that an association to be named as-

PAKISTAN SINGLE WINDOW

is to be formed as a public limited company under the Companies Act, 2017, with the primary object "To act as an Operating Entity of Pakistan Customs, Revenue Division, Federal Board of Revenue, Government of Pakistan, Islamabad, in implementation of 'Pakistan Single Window' project and all related initiatives aimed at facilitating processing of cross border trade related regulatory approvals and transactions under The Customs Act, 1969 (IV of 1969); The Customs Rules, 2001 and Pakistan Customs Tariff under Fifth Schedule to the Customs Act, 1969; through a Consolidated Electronic Platform including registration, application of all regulatory documents, submission of trade declarations, review, approval and processing of such applications and declarations, electronic payments including but not limited to Customs Duty, import and export duties / taxes, business process mapping, simplification and process re-engineering, harmonisation and standardisation of data elements, information exchange, adoption of modern technology and risk-based selectivity in enforcement of government's regulations, renting, procuring or developing software and hardware etc." and it (a) intends to apply its profits and income towards those objects and (b) prohibits the payment of any dividend or profit to its members (c) ensures that its objects and activities are not and shall not, at any time, be against the laws, public order, security, sovereignty and national interests of Pakistan.

2. Now, therefore, in pursuance of section 42 of the Companies Act, 2017, the Commission is pleased to grant licence to the said Association and direct that it may be registered as a public limited company without addition of the words "Limited" or "(Guarantee) Limited" to its name.

3. This licence is granted for a period of three (3) years subject to other conditions as mentioned in the Association with Charitable and Not for Profit Objects Regulations, 2018 or any other additional condition(s) where mentioned overleaf.
